



## CMA honours 2 medical pioneers, administrator

The CMA presented its top awards during the August annual meeting in Victoria. The 1997 recipient of the **F.N.G. Starr Award** is Dr. **Robert Salter**, an innovative orthopedic surgeon whose work improved the treatment of millions of pediatric patients. In 1962 his research with Dr. Robert Harris led to the Salter-Harris classification of epiphyseal plate fractures, which classifies these fractures according to the prognosis of the effects of the injury on subsequent growth and deformity of the epiphysis. He also developed the Salter innominate osteotomy and the concept of continuous passive motion (CPM) to treat diseased or injured cartilage. CPM employs machines to move joints continuously postoperatively.

The F.N.G. Starr Award is the highest honour the CMA can bestow upon a member. It recognizes outstanding contributions to science, the fine arts or literature. Salter, a 1948 graduate of the University of Toronto, has published more than 150 articles and is currently surgeon-in-chief emeritus and senior orthopedic surgeon emeritus at Toronto's Hospital for Sick Children. He is a companion of the Order of Canada and has been appointed to the Order of Ontario.

The **CMA Medal of Service**, which is presented to a physician who has made an exceptional and outstanding contribution to the advancement of health care in Canada, was awarded to Dr. **A. M. (Max) House**, a

telemedicine pioneer. A 1952 graduate of Dalhousie University, House became Newfoundland's sole neurologist in 1960. He helped create the Memorial University medical school and was its first director of continuing medical education when it opened in 1968. In 1976 he founded the Telemedicine Centre at Memorial, establishing him as a worldwide leader in the field. The centre is still recognized internationally as the model for telemedicine systems. His use of communication technology to deliver care elevated the standard of medical care in some of Canada's most remote locations.

House became a member of the Order of Canada in 1989 and retired from his neurology practice this year to become lieutenant-governor of Newfoundland and Labrador.

The 1997 recipient of the **Medal of Honour**, the highest award the CMA can bestow on a person who is not a member of the medical profession, is **Peter Fraser**, the first non-physician to serve as chief executive officer of the Ontario Medical Association (OMA). As OMA comptroller in the 1960s, Fraser codified the schedule of fees that became the basis of the payment schedule for Ontario's medical insurance plan. Fee schedules across Canada can trace their form and often their substance to the blueprint he created.



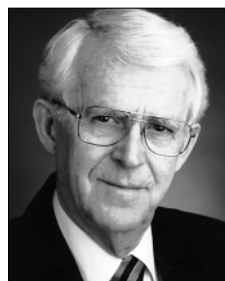
